We are pleased to once again be able to offer bursaries to our ONA members to further their education or the education of their children. Please see the attached documents and application forms. If you have any questions, please ask your Bargaining Unit President or call the Local 100 office.

One (1) \$1000.00 for LHSC MRT&D members to use to expand their knowledge (can include a course, workshop, conference, etc.)

One (1) \$1000.00 bursary shall available to MRT&D member's child who is enrolled in post-secondary education.

Applicant Eligibility Criteria and Conditions

1. Applicants must be bona fide Local members with entitlements.
2. Bursary funds will be provided to successful applicants upon proof of completion of the education. The successful applicant shall endeavor to complete the education within 12 months of notification of bursary approval.
3. You are asked to provide your SIN number in order for ONA to issue T4A.

Application Procedure

1. Applications must be received no later than June 1 of each calendar year.
2. Applicants should use the application form appended to this policy.

3. Successful applicants will be notified via email by June 15. Any bursaries not awarded or any bursaries remaining unclaimed for greater than 45 days will be distributed amongst those members who submitted applications for the current year but were unsuccessful.
4. The Local Executive will determine the final selection based on the recommendation of the Local Coordinator. All selections are final and not subject to review.

Executive Members of the Local will not be eligible for a bursary.
